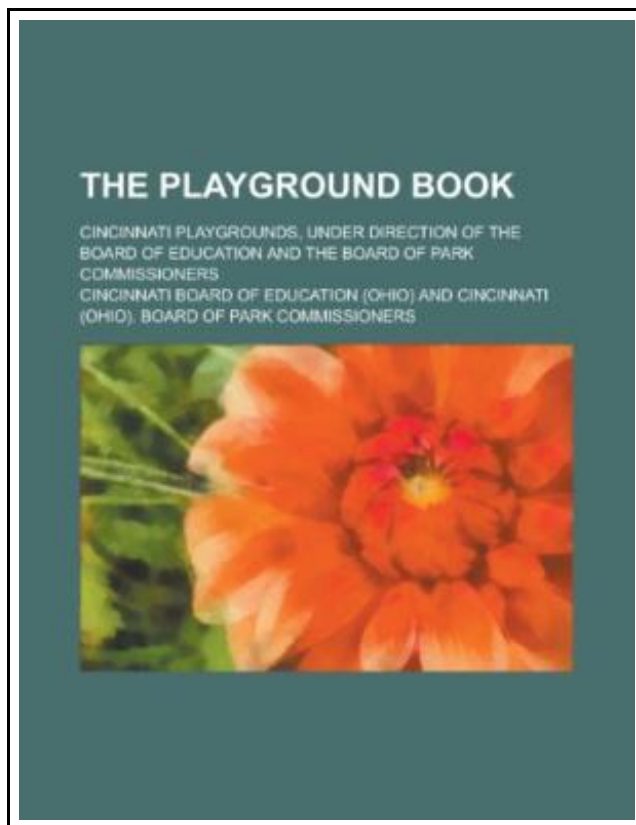

Excerpt: .two halves of 15 minutes each, with an intermission of 10 minutes. The team having the ball at the end of the first half, shall start the play at the beginning of the second half. Should the ball be in play when time is called, the team not having the ball at the opening of the game shall start the play in the second half. 4. The captains are appointed by the instructor, and their term of office expires at the close of the game. For match games, the captain may be selected by the team. The captain gives the players their positions on the court. He is the only player who may talk to the Referee during the game. 5. The game may be opened in two ways. (1) The captain, who secures the toss-up opens the game. (2) The game is opened by the Referee (or instructor) who stands on the division line and tosses the ball up between the captains. The captains shall stand at the least 3 feet apart, measuring from the advanced foot. The Referee shall see that none but the captains try for the toss-up. When a captain has secured the ball, either by catching or batting it into his own court, the game is not formally opened until the captains have returned to their respective positions, in the forward center of the court, and the Referee gives the signal (whistle) to play ball.
